Please read the following information when registering:

--Conditions

1.Services Offered

(1) ICS Japan Co., Ltd. will offer ICS DIRECT international phone service under the conditions mentioned below.

(2) This form is for registration of the said service.

(3) Whether a corporate user or a residential user, payment will be effectuated by account transfer. However, a representative of the former, or the latter himself/herself or his/her family member will submit a credit card number and signature for reasons of security. ICS has the right to withdraw the cost of calls from the card account if necessary.

(4) In case of (3), ICS may entrust a third party to withdraw the amount due.

2.Cost

The cost of this service will be calculated according to tariff set by ICS.

3.Statement and Payment

(1) ICS will claim the cost of calls at the end of every month and will claim it from the bank or a credit card company designated by the user.

(2) Based on above, the payments of this service will be effectuated as stated in <Agreement of Deposit Account> and <Rules for Credit Card Users>.

4.End of Service

(1) The use or offer of this service will end after both ICS and the user has been made aware of this fact.

(2) ICS may end the offer of this service without notice under the following situations:

-If the user is notified by the credit card company that he/she is no longer able to meet the payment due.

-If the user does not abide by the conditions agreed upon.

(3) To end the use or the offer of this service, ICS will promptly delete the registered telephone number and thereby consider the service terminated.

--Attention

-Credit card is necessary for registration for both corporate and individual users. The required documents are: application form with credit card number, signature, telephone number etc. filled in, and application form for deposit account transfer (a green form).

-If the claim cannot be made from the bank account, the claim will be made to the credit card company in name of a third party entrusted by ICS.

-<Japan Lease Co.> will make the above claim.

-The cost of the service will be calculated at the end of every month and will be paid in lump sum.

-A detailed statement will be sent to the user. The details on the statement are date, length, country, number and cost of all calls made.
